General terms of The Peter Jones Foundation Virtual Fundraiser (the "Fundraiser"):

- 1. The Fundraiser is provided by CharityStars, Inc. ("CharityStars") on behalf of The Peter Jones Foundation (England and Wales company number 05321690), Charity Commission for England & Wales charity number 1110288) ("PJF").
- 2. The Fundraiser platform is available on the CharityStars website at: https://www.charitystars.com/peterjones (the "Website")
- 3. These Terms and Conditions apply *in addition to*:
 - (a) the Terms of Service of CharityStars, available at: www.charitystars.com/company/tos (the "Terms of Service");
 - (b) for each Sweepstake Prize only, the Sweepstake Official Rules applicable to that Prize available on the Website page for the relevant Sweepstake Prize;
 - (c) the terms and conditions specific to a Prize, which shall be available on the CharityStars Website:
 - (d) any additional terms and conditions of a Prize sponsor/prize donor relating to the relevant Prize; and
 - (e) any other terms and conditions of CharityStars,

(together, "TOCs").

- 4. There are two separate parts to the Fundraiser with a chance to win one of the advertised prizes in the Fundraiser ("Prize"):

The condition, authenticity, quality or adequacy of any Prize shall be the sole responsibility of the prize donor/sponsor/provider.
- 22. PJF's maximum and sole liability to an individual under the Fundraiser is set out at clause 14 of these Terms and Conditions; the sole remedy for such individual shall be the Refund. Nothing in the TOCs shall exclude or limit PJF's liability to the extent that such liability cannot be lawfully excluded or limited.
- 23. These Terms and Conditions are governed by and construed in accordance with English law (including in respects of non-contractual disputes and claims) and the parties submit to the exclusive jurisdiction of the English courts.
- 24. No provisions of the TOCs shall affect any legal right of Entrants.
- 25. Nothing in these Terms and Conditions shall exclude or limit liability for:
 - death or personal injury caused by the negligence of a party, its officers, employees, contractors or agents;
 - b) fraud or fraudulent misrepresentation; or
 - c) any other liability to the extent that the same cannot be lawfully excluded or limited.
